## INFORMATIVE DOCUMENT ORDINARY GENERAL MEETING OF SHAREHOLDERS OF COMVEX

Starting with January 25, 2024 the mandate granted by the Ordinary General Meeting of Shareholders of Comvex S.A. to the financial auditor PRICEWATERHOUSECOOPERS AUDIT S.R.L.
